

Overview

The Responsible Care® & Sustainability Future Leaders (RCSFL) Program is a joint initiative led by American Chemistry Council's (ACC) Responsible Care and Sustainability Departments. The goal of the program is to help prepare high-potential, young professionals within the chemical manufacturing industry for challenges of the future. It is designed to provide exceptional learning and exposure opportunities for skill development and peer networks to the accepted nominees who are dedicated to advancing in the chemical manufacturing industry.

Nominations for the program should be for ACC member company employees that demonstrate a high potential for positive industry impact within the environmental, health, safety, security (EHS&S) and sustainability disciplines. They should be early career professionals with no more than 10 years of experience within the chemical industry and have core job functions in Responsible Care and/or Sustainability.

The application form should be submitted by the member company's Responsible Care or Sustainability Coordinator ("Nominator"), and include expression of interest from the nominee, acknowledged time commitments from the nominee's supervisor (if different from the nominator), and may include a mentor for the nominee to help hold the nominee accountable throughout the program if selected to participate. The mentor may be the same person as the supervisor and/or nominator but must hold a position/title that is more senior than that of the nominee.

If selected, a non-refundable program tuition fee of \$2,500 is required to participate in the annual program. This cost will cover food and lodging booked by ACC staff for the three in person seminars. (See page 3 for full schedule). The remaining program cost is covered by ACC.

March

April | 16-19

Seminar I: Program Onboarding Webinar

July
