Chemical Distributor Affiliates that buy chemical products or product lines and resell them to customers, including taking title of products, and typically providing full distribution capabilities, logistics and transportation, and possibly repackaging, compounding, or blending of products. These Affiliate Chemical Distributors may do some limited manufacturing of chemicals, but distribution sales represent the majority of revenue for the company.

Chemical Handler Affiliates that warehouse or transport chemical products for producers or distributors, but do not typically take ownership of products. These handlers may also recycle or recondition containers, or perform primarily warehousing, trucking, or logistics functions.
