



MRFF FLEXIBLE PLASTIC PACKAGING (FPP) PILOT SELECTION SUMMARY

The RRS inventory of U.S. MRFs as of February 2017, were evaluated against a set of success criteria that included technical, policy and management factors to identify a qualified MRF partner for the FPP pilot program. MRF operators were consulted through a series of discussions that included both webinars and onsite visits. A priority list was identified of the most qualified candidates. On site assessments were performed where MRF management indicated a willingness to explore a project.

A highly-qualified candidate was identified in May 2017, so further discussions with other MRFs were placed on hold.

EVALUATION CRITERIA

- MRF throughput \geq 20 tons/hr
- Single stream MRF
- MRF ownership willingness to add material
- Community support Interested in adding FPP to recycling collections
- Supportive regulatory/economic environment
 - Encourages increased diversion
 - Large FPP stream available to MRF
- Existing end markets in region drive value proposition
- High tip fees favorably impact MRF net system cost
